**CALL TO ORDER:** The meeting was called to order at 10:00 a.m. by Supervisor Krupke.

**PUBLIC COMMENT:** No public comment

**SUPERVISOR REPORT:** A motion to accept the Supervisors Report for November 2020 was made by Councilwoman Gilson and seconded by Councilwoman Haynes. In a roll call vote, all were in favor with a vote of "AYE".

**WARRANT OF BILLS:** Next Abstract #13. A motion to pay abstract #13 was made by Councilman Goodsell and seconded by Councilwoman Gilson. After a brief discussion about the use of the Town Credit cards, a roll call vote was taken all voting "AYE".

**MISCELLANEOUS BUSINESS:** With everything taken under consideration, all the money from New York State is better than expected. Starting with the Towns share of sales tax. The Town budgeted for \$160,000. The actual total was \$183183.05. Much better than what was

expected. The State has sent the AIM money of \$40,000, which was very unexpected. With New Homes sales in the area, the amount of money that was expected from new mortgages is up from \$45,000 to \$127,700. The Town had budgeted \$150,000 for the Town Court and at this time the Court has only brought in \$46,000. This is not the final total for the Court. The Court still hasn't reported November or December totals as of today.

Councilman Yerdon and Councilwoman Gilson have been working on the Teamsters Contract. It was agreed that the Contract will be extended for another year. The only changes are the 2% payroll increase and the Health Insurance will increase \$24.43 per month per employee.

Everything else will stay the same. A motion to accept the extension in the Union Contract with the noted changes was made by Councilwoman Haynes and seconded by Councilman Goodsell. In a roll call vote, all were in favor with a vote of "AYE". The next Regular Town Board Meeting will be on January 12, 2021 and a joint Town, Village and Comprehensive Board Meeting will be held on January 14, 2021 at 6:00pm in the Auditorium at the Pulaski Village Office.

Councilwoman Haynes has some concerns with all the Boards meeting at that time especially with the Covid numbers on the rise. The Board agreed to postpone the meeting until sometime in February in hopes that the number of infections start to drop. Supervisor Krupke will contact Mayor Tighe to reschedule the meeting. The Comp Plan was emailed to all Board Members. Councilman Yerdon would like to see things broken down for the Village, Town and Town Wide to make it easier to follow and understand. Supervisor Krupke will reach out to Comp Board Chairperson, Dawn Holynski to see if she could come to the next Board Meeting 1 hour before to talk about the possible changes.
