PROGRESS REPORT June 1, 2024 to August 31, 2024

Objective 1: Provide the Town of Richland with grant writing services to continue to implement the recommendations of the Town's Comprehensive Plan, in addition to other projects and programs as directed by the Town of Richland.

Objective 2: Provide technical assistance to the Supervisor, Board of Trustees, and other Town staff on a wide range of topics.

Accomplishments

Richland Pocket Park Project -**Now that this project has a fully executed contract between NYS and the Town of Richland I will no longer bill my time to this contract.

<u>Salt Storage Shed</u> — Provided information to the Town regarding the CFA funding opportunity for this project; however, the Town decided to pursue the project and issue an RFP without applying to CFA. After the CFA deadline, I was notified that the Town opened the bids and they now decided to postpone the project and pursue grant funds. So, I reminded them of the CFA process and timing for proceeding with this project so that they were aware of everything including the likelihood that construction would take place in Spring 2026 at the earliest if they apply and receive a 2025 CFA (WQIP) grant.

<u>Guardrail Project</u> – I reviewed the information provided by K. Balcom and began researching funding opportunities. I participated in a conference call with NYS DOT staff (M. Kelly and R. Sawczak) to discuss the project and funding options. I then requested additional information from K. Balcom and reported all my findings to him for consideration of how to proceed.

Water Tower Project – I reviewed the Town's request for assistance with the replacement of the water tower. I researched several different funding options, contacted the NYS DEC staff with grant funding program questions, reached out to USDA RD staff for clarification on their program, and reviewed the WIIA options. I summarized all the information and presented it to the Town officials.

<u>Pro-Housing Community Initiative</u> – I provided program information to the Town regarding the initial steps to becoming a Pro-Housing Community. I have not heard back on whether they'd like to pursue this, with my assistance, or not.

<u>DASNY Grant</u> – Continued to correspond with DASNY staff after submittal of the final payment request. Received and forwarded notification to town officials that their final payment was approved, based on an email from DASNY in late-June. This project is now closed.

<u>CNY Community Foundation</u> — We received an award from the CNY Community Foundation for the Richland Pocket Park Project. I reviewed the contract award materials and offered to provide assistance with the required progress reports. I also prepared and sent a draft press release to J. Peterson for revision and distribution to local media outlets.

<u>Communication and Meetings</u>: I prepared for and participated in the Town's project planning meeting on June 4 including creating a handout to guide the discussion and taking notes on priority projects to pursue funding for. I maintained communication with Town employees and Town Board Members throughout this period.

RESOLUTION

AUTHORIZING REQUEST FOR REDUCTION OF SPEED LIMIT ON TOWNE ROAD

WHEREAS Towne Road is a rural Towne Road located within the Town of Richland accessible by New York State Route 13 and County Route 28 which is without a posted speed limit; and

WHEREAS Towne Road gets an excessive amount of morning and evening work commuter traffic from State Route 13 area for quicker access to County Route 28, to State Route 81

WHEREAS several residents on Towne Road have approached the Town requesting a reduced speed limit due to multiple areas of straight aways on the roadway, the excessive amount of commuter traffic and Amish horse and buggy traffic; and

WHEREAS a Petition having been filed with the Town requesting that the speed limit get reduced on Town Road within the Town; and

WHEREAS pursuant to applicable New York State Laws, including the Town Law, Highway Law, and §1622 of the Vehicle and Traffic Law, the Town Board is required to adopt a Resolution requesting a reduction of the speed limit; and

WHEREAS the Town believes it to be in the public's best interest to make such a request of the NYS DOT to reduce the speed limit to 45 MPH; and
